

## Essay/Poem Submission Agreement

We are delighted you are interested in submitting your essay and/or poem to the Fredericton Region Museum (FRM) cancer exhibit. You will retain copyright ownership of your essay and/or poem, however, you are granting the FRM and York Sunbury Historical Society (YSHS), the license to duplicate, display, transmit, etc. your essay and/or poem, in all media and to be included in our archival collection. Any profits from this work will be used to continue the operation of our organization. The FRM is operated by the YSHS and is a non-profit organization established to collect, preserve and interpret historical data, records and objects relating to the history of the province of New Brunswick, and in particular that of York and Sunbury Counties.

By submitting an essay and/or poem to the FRM, and agreeing to the terms of this Submission Agreement, you affirm that this essay and/or poem is original to you, that you own the copyright to this work; no other person owns rights to this essay and/or poem, and that the essay and/or poem does not defame or otherwise violate the rights, copyrights, trademarks, privacy, or reputation of any third party.

You grant the FRM and YSHS, a non-exclusive, assignable, transferable, royalty-free, perpetual, world-wide, and permanent license to duplicate, display, distribute, excerpt, perform, or transmit the essay or poem in any format or media known or hereafter known. The FRM and YSHS shall have the right to own or register copyrights to any works or compilations created by the FRM, that contain the essay and/or poem, in whole or in part.

You agree to indemnify and hold the FRM and YSHS harmless against any claims asserted by any third parties that allege the essay or poem violates their rights, or from any breach by you of your promises in this Agreement. You shall be responsible for any costs incurred by the FRM and YSHS for defense or settlement of third-party claims, including, but not limited to, reasonable attorneys' fees of the FRM and YSHS.

You understand that submitting an essay and/or poem does not guarantee that your work will be used, displayed, or otherwise reproduced. Essays and poems may be archived for public use, or reproduced in audio form, published in print or online, or in any other way. The decision of which and how essays and poems, will be used will be at the sole discretion of the FRM and YSHS.

You agree to allow the FRM and YSHS and its assignees to use your name and approved visual(s) in publishing, promoting, marketing or otherwise distributing your essay and/or poem. You grant the FRM and YSHS the right to use a picture provided by you to promote your essay and the exhibit online, in print, in visual displays and for other ancillary uses.

This Agreement does not give you the right to use any names, images, trademarks, or service marks owned or licensed by the FRM and YSHS or any other sub-licensees.

You affirm that you are at least 18 years of age and possess the legal right and ability to enter into this Agreement, or that you are the parent or legal guardian of the minor who is submitting the essay and/or poem.

This Agreement represents the entire understanding of the parties and supersedes all prior agreements (whether written or oral), if any, with respect to the subject matter of this Agreement. This Agreement may only be modified or amended by a writing signed by both parties.
